Rules for licensed fishing:

- Licensed fishing, crayfishing and underwater hunting in the Radžu reservoir takes place in accordance with the Cabinet of Ministers' regulations of December 22, 2015 No. 800 "Fishing, crayfishing and underwater hunting regulations", subject to the following additional conditions:
 - licensed fishing from boats is allowed from May 15 - until the first ice (until the Radžu reservoir freezes); crayfishing is allowed from July 1 to September 30;
 - underwater hunting is allowed in the entire Radžu reservoir, except for the public swimming area and the area from the swimming area to the recreation base "Radži" (the area marked with a red line in Appendix 1 of the regulations) during daylight and dark hours from June 1 to December 31, or until the first ice. (until the Radžu reservoir freezes), whichever comes first.

• the following bag limits of fish species are allowed to be stored and kept by one angler and underwater hunter for the day:

- ☐ pikes, zanders - 3 pcs. of each species;
- ☐ catfish - 2 pcs.;
- ☐ tench - 5 pcs.;
- ☐ bream - 5 kg;
- ☐ carp - 5 kg;
- ☐ eel - 1 pc.;
- ☐ grass carp and silver carp are not allowed to be kept and have to be carefully released
- ☐ fish of other species not mentioned above - 5 kg in total.

Licensed fishing in the Radžu reservoir is allowed from the shore (using a 4 m towpath), from ice, from watercraft (boats etc.), as well as wading into the water.

Environmental and natural resource protection requirements

The fisherman is obliged to:

1. present a valid fishing card for Latvia, ID document, relevant fishing license for Radzu reservoir, fishing tools and catch for control at the place of fishing;
2. treat nature with care, not to pollute the water body and its coastal area;
3. fill out a licensed fishing catch count table

Reporting the catch

All license holders, regardless of their type, must register their caught fish in the license report's catch table, at the end of the day - date, fish species, catch size (number and weight of fish).

Catch report deadlines:

- one-day licenses – within 5 days from the day of use;
- annual licenses – until January 5 of the following year.
