

### **Licenced fishing terms and conditions**

1. Licensed fishing is stipulated throughout the territory of Lake Vaidava and along the section of the River Strīķupe that flows out from it from Lake Vaidava to the V192 Highway Vaidava–Rubene Bridge (hereinafter referred to in the text as – Lake Vaidava) (Annex No. 1).

2. Licensed fishing on Lake Vaidava may be carried out from boats and from the shore, as well as on the ice during the winter season, in accordance with Cabinet Regulation No. 800 of 22 December 2015 “Fishing, Crayfishing and Underwater Hunting Regulations” (hereinafter – Fishing, Crayfishing and Underwater Hunting Regulations).

3. A fisherman, who practices licenced fishing, must present:

10.1. A personal identity document;

10.2. A fishing licence;

10.3. During the relevant period of time, a valid fishing, crayfishing and underwater hunting card (if fisherman is one of the persons who must possess such a card, in accordance with Fishing, Crayfishing and Underwater Hunting Regulations);

10.4. Persons with disabilities aged from 16 to 65 years – a disability certificate.

4. In order to conserve resources of large predatory fish, and in accordance with the “Terms and Conditions for the Use of Fisheries for Lake Vaidava in 2022”, one person is permitted to keep fish of the following species in their catch:

10.1. two pike;

10.2. two pike perch;

10.3. two eels;

10.4. other species of fish – in conformity with Fishing, Crayfishing and Underwater Hunting Regulations.

5. A fishing licence is issued to a specific private individual and it is prohibited to give it to other persons.

### **Licence types and prices**

6. Licence types and prices:

1.	One day licence for fishing on Lake Vaidava	4.00	Valid one day licence on the specified date
2.	One week licence for fishing on Lake Vaidava	8.00	Valid seven day licence during the specified period of time
3.	One month licence for fishing on Lake Vaidava	15.00	Valid one month licence during the specified period of time

4.	One year licence for fishing on Lake Vaidava	30.00	Valid during the period from 1 January to 31 December
5.	Free one year licence for fishing on Lake Vaidava	0.00	Valid during the period from 1 January to 31 December

7. All types of licenses entitle the licence holder to fish from the shore, a boat or on the ice. There is no limit on the total number of licences.

#### **Application of fishing licence price discounts**

8. Free licences are provided for:

- 14.1. Owners of land along the shores of Lake Vaidava;
- 14.2. Children and teenagers up to 16 years of age;
- 14.3. Persons over 65 years of age;
- 14.4. Politically repressed persons and persons with disabilities;
- 14.5. Persons from families, which have been awarded a Latvian Family of Honour Certificate in accordance with the nationally implemented Latvian Family of Honour Certificate Programme.
- 14.6. While fishing, recipients of free licences must possess a document certifying their right to use this free licence.

#### **Fishing licence contents and requisites**

9. The following requisites are specified in the licence:

- 15.1. Licence type;
- 15.2. Series and number;
- 15.3. Price;
- 15.4. Term of validity;
- 15.5. Name of the relevant water body (Lake Vaidava, River Strīkupe section);
- 15.6. Information about the licenced fishing, crayfishing or underwater hunting organiser;
- 15.7. Licence recipient and his or her personal identity code number;
- 15.8. Phone number and e-mail address used for communication;
- 15.9. Licence date of issue.

#### **Licence production and sales**

- 10. Licences can be bought or received on the website: [www.manacope.lv](http://www.manacope.lv) and on the mobile app: "Mana Cope".
- 11. The value of licences not used for fishing or rescinded because of violations will not be reimbursed to fishermen.
- 12. A person may buy a fishing licence for another person by specifying his or her name, surname and personal identity code number.
- 13. When buying a fishing licence, Latvian citizens must indicate their personal identity code number, where citizens of other countries must indicate the number of the person's identity document or

personal identity code number.

14. One person cannot possess more than 3 (three) active licences without recording a catch.

15. It is not necessary to print out an electronic licence, and its existence will be checked according to its number.

### **Recording catches**

16. After keeping their catch, it is mandatory for all licence holders to register their catch, the species of fish, size the catch (number of fish and weight), submitted them to the website: [www.manacope.lv](http://www.manacope.lv) or to the mobile app: "Mana Cope".

17. Within 5 (five) days of the expiry of the term of validity of his or her license, a fisherman is obliged to submit a report of his or her record of catches. The licenced fishing organiser will register the persons, who have exceeded the catch record limit stipulated in the rules, and, using the phone number or e-mail address specified on the licence, inform the fisherman of the need to submit a catch report within 14 (fourteen) days. If the catch report is not submitted within the aforementioned timeframe, the organisers shall notify the fish resource protection and supervisory bodies about the violation ascertained.
